

## Guidelines for Selection of the Queensland Polocrosse Management Committee Awards

- 1. The nominee cannot hold a current Management Committee or Executive position with the Queensland Polocrosse Association.
- 2. The nominee is a person, or group of people, who have made an <u>outstanding contribution</u> to polocrosse during the previous year, or over a period of time.
- 3. The recommended person or group must be nominated in writing by a Club, Zone or QPA Management Committee and seconded in writing by a Club, Zone or the QPA Management Committee. The proposal needs the signatures of the mover and seconder attached.
- 4. All player awards to be awarded within age group only.
- 5. Each recommendation will be accompanied by a written profile of the person or group outlining their achievements.
- 6. Nominations need to be at the QPA office by the closing date.
- 7. The State Administration officer will acknowledge receipt of the nomination in writing.
- 8. Nominations will be forwarded to the relevant state selectors whom are to select 2(two) people
- 9. The Management Committee will then vote by a secret ballot at the October Management Committee meeting.
- 10. The Management Committee reserves the right not to present these awards if it considers a suitable candidate has not been presented.

Arthur Earl Patrons Trophy	Not necessarily awarded every year. Denotes a lifetime of commitment at the highest level to polocrosse, cannot be a serving member of the MC.	Any financial member can be nominated via a Club, must be seconded. MC final decision.
Hall of Fame inductee	Managers/coaches/players that have reached the top of their game. Outstanding achievement in and for services to the sport of polocrosse.	Management Committee
QPA Life Membership	Not awarded every year. Awarded to an individual in recognition of exceptional service to polocrosse in competition and/or administration over many years.	Any financial member can be nominated via a Club or Zone must be seconded. MC final decision.

Junior Player of the Year	Outstanding Junior Female Player for the year Outstanding Junior Male Player for the year	Any financial member can be nominated via a Club or State Selectors. Club nominations must be seconded. MC final decision
New Zealand Junior Scholarship Winner	Junior player to travel to NZ in January as an ambassador for polocrosse. Must be a good ambassador of Queensland and a competent player and rider.	Members self-nominate, seconded by Club, MC final decision
Australian Stock Horse Society (ASHS)	Rookie horse; Ladies & Mens Open horse; Ladies, Mens Juniors	Members nominate through their zone. Zones to send through completed forms
